NOW, THEREFORE BE IT RESOLVED, that the Ulster County Transportation Council adopts this Amendment to the UCTC 2020-2024 TIP as shown in Attachment 1; be it further

RESOLVED, that the Director of the Ulster County Transportation Council authorizes the Secretary to transmit the TIP Amendments to the New York State Department of Transportation (NYSDOT) and Federal Highway Administration for STIP approval.
