**5. New Business**

**a) Resolution 2023-04: Allocation of Previously Unallocated Federal Transit Administration (FTA) Section 5307 Formula Funds for Regional Transit Projects.**

Resolution 2023-04 allocated \$0.500 in unallocated FTA Section 5307 funds attributable to the Mid Hudson Valley TMA to Ulster County for the purpose described below.

UCAT currently has several designated bus stops without shelters and its existing shelters are outdated and in need of replacement. In addition, the system also uses a flag stop system along its major routes. Several of these flag stops are now associated with regular users and UCAT would move to provide shelters at these locations. The primary focus of new shelters would be in the City of Kingston and the

Town of Ulster and in the Villages of New Paltz and Ellenville. Better shelters are also under consideration at our hubs where multiple routes converge. Shelters would ensure that ADA requirements for boardings and alighting can be met; further, providing better shelters would reduce the need for flag stops on several routes. The shelter upgrade project is anticipated to be completed withing 24 months of programmed funding. Likely in FFY 2024.

If approved, the Mid Hudson Valley unallocated balance will be reduced to \$8,219,647 available for future program for regional transit needs.
