SUBJECT: Development of the FFYs 2025–2029 Transportation Improvement Program

The Ulster County Transportation Council (UCTC) is notifying local municipalities within the Ulster County Metropolitan Planning Area of the start of the 2025 UCTC Transportation Improvement Program (TIP) update process. As mutually agreed between New York State Department of Transportation (NYSDOT) and the NYS Metropolitan Planning Organizations (MPOs), UCTC will begin to update the TIP for Federal Fiscal Years 2025-2029, effective October 1, 2025.

The UCTC Technical Committee will review existing projects programmed on its current TIP against anticipated federal transportation fiscal targets available for the FFYs 2025–2029 TIP cycle and begin the update according to the following schedule and process.

TIP Development Schedule and Process

The TIP update process requires the delivery of an approved, fiscally constrained TIP by June 2025 for inclusion in the State Transportation Improvement Program (STIP).

UCTC will immediately schedule meetings with existing project sponsors to discuss any necessary changes to project schedules and budgets (see list of projects under Attachment 2, page 3). In addition, UCTC anticipates funding to be available for distribution under several funding categories, including the STBG Off System Bridge, Highway Safety Improvement, and Carbon Reduction programs. The process for applying for these funds will be developed in coordination with the UCTC Technical Committee or TIP subcommittee.

The process for updating the TIP is detailed within the UCTC Operating Procedures, available online at https://uctc.ulstercountyny.gov/wp-content/uploads/2024/10/mpo_op-1.pdf

The TIP is a 'fiscally constrained' program of projects that must demonstrate to the Federal Highway Administration and Federal Transit Administration that sufficient funds (Federal, State, local, and private) exist to implement the proposed transportation system improvements, as well as to operate and maintain the entire system. In addition, projects must be consistent with UCTC's Long Range Transportation Plan. UCTC fiscal targets for the 2025 TIP update cycle are shown on Attachment 1, page 2. These funds are typically made available to sponsors of locally-administered federal aid projects currently programmed on the approved UCTC TIP prior to solicitation for any new projects. All locally-administered federal aid projects with phases scheduled for FFYs 2025 – 2029 are shown in Attachment 2, page 3.

Planning Organization (MPO) for Ulster County and a portion of the Poughkeepsie-Newburgh Urbanized Area.

The UCTC was designated by the Governor of New York as the MPO for the Kingston Urbanized Planning Area on April 30, 2003. The UCTC was formally organized with the adoption of Operating Procedures on June 4, 2003. The purpose of the UCTC is to build a consensus on local and regionally significant transportation, transit and non-motorized improvements.
