The tip is the capital program arm of metropolitan planning organization and keep going. Chris.

UCTC: Those tips once approved, get rolled into what is called the Statewide Transportation Improvement Program, which is essentially a compendium of all the 14 Mpo tips plus the rural program the New York State dot admin.

UCTC: So we're dealing with Fhwa funding, Federal highway administration and Federal transit fta funding

UCTC: and the main components here are highway bridge and bike and pent projects. Mobility projects transit. And then Dot has a very significant component of multi county projects, as well as some local projects that were added to this program.

UCTC: In the past New York State thruway authority and bridge authority have used federally, but they have don't have any Federal aid projects included on this transportation improvement program.

UCTC: The process is that dot provides us with a fiscal target. Essentially, the amount of money we have to program.

UCTC: and that occurred in November, and we take it from there the Uctc Technical Committee and staff work specifically to update the local projects. Those are projects sponsored by local municipality, using Federal aid to carry through and update whatever needs to be updated on those projects. And if we have money to add, then we add.

UCTC: and then we've been fine tuning it in the past several months to get to the point where we're at today.

UCTC: Of course, it's running under the bipartisan infrastructure law which has made that these dollars available.

UCTC: And we looked at the projects that are currently on the transportation improvement program and what dollar amounts they may need. And we determined very quickly that the majority of our Stbg flex target was going to be absorbed by the existing needs of existing projects already



programmed. Nonetheless, we did have a few dollars, not a few. We had significant funding for our bridge program

UCTC: and the highway safety improvement program allocation. So we issued an expression of interest, call for project proposals which was mailed to all municipalities.

UCTC: This is a summary of all the dollars that are programmed on the current transportation improvement program.

UCTC: So what did we do with the target town of Lloyd Tilson Avenue project, which is complete, did have a deficit of one over 1.4 million, so we were able to provide Federal aid of 1.4 million, and the town is required to provide 20% match to that same for Ulster County route, 299 shoulders, and the towns of New Pulse and Gardner. That project is scheduled for construction, obligation this fall

UCTC: and that project was short. Over 1.7 million dollars. So part a major portion of the target was provided to that project.

UCTC: The Town Gore Creek Bridge, which is a Dpw. Or Ulster county Dpw. Project required funding, then other existing obligations. So our main target of dollars, Stpg flex, which is a great program because you can spend it on any surface transportation project, bridges, trails, roadway projects.

UCTC: that 5 million dollars was absorbed by the the needs of the existing system. So we had, I think, a small amount of money available roughly, \$300,000 in federally left over. That is

UCTC: you know, still eligible to be programmed on on future projects. But it's not enough to fund a standalone project.

UCTC: Go ahead next slide. We also, for the 1st time in recent memory, had a target of highway Safety Improvement Program funding. We thank the Department for for providing that as well, and



we have an existing project on the tip. The Boise Lane project in the town of Ulster that's sponsored by town of Ulster.

UCTC: It did have a deficit of its own. So 1.4 million in Federal aid was provided to that project. This is a signal coordination project at this rather complicated crossing of Boise Lane and 2 adjoining intersections along with the Csx. West Shore Railroad, so there will be improvements made to the signal

UCTC: timing and infrastructure in that location, as well as upgrades for pedestrian accommodations going forward.

UCTC: we had a significant over 12 million dollar target for our off system bridge program. Those are off system refers to off of the Federal aid highway system. So they're largely borough bridges. It's money that's typically targeted toward rural bridges. Towns and Ulster County are what the the

UCTC: And we're able in this iteration to program 2 brand new bridge projects, one in the town of Warsing for the Barber Road Bridge and another in the town of Lloyd for the Will Dock culvert, which will be converted into a bridge, therefore, making it eligible for the funding source. These locations are what are considered to be high criticality locations, and that

UCTC: the communities or neighborhoods that are served by these bridges have only one way in and out and that is utilizing these bridges. And so the replacement is

UCTC: while they're small bridges and they don't get a lot of traffic. They're highly critical to those individuals who use them. So we feel they're good investment.

UCTC: And we have held over for future programming for off system bridges, 5.7 million dollars in Federal aid that is included on what we call block PIN. So it's held essentially in savings. And we'll discuss with Dot the best strategy for releasing those funds going forward, and I would say to any municipality that has a rural bridge concern, they can reach out to our department at any point in time

UCTC: Let's not forget about the Fta side. Federal transit administration aid. This Council deals with the appropriation of those dollars

UCTC: several different sources of Federal aid, including Fta. 5,307, that is attributed to the Kingston urbanized area, and section 53 0. 7, attributed to the Poughketsey, New Bern urbanized area, both of which

UCTC: cover portions of Ulster County. So we get significant funding from those sources as well as another source called Fta 53, 39.

UCTC: In this tip we're looking at a variety of capital improvements to the rolling stock, 1 point 2 5

UCTC: 1 million for the design of a new Ucap bus storage facility. That's simply for the design.

UCTC: Another one and a quarter 1 million for upgrades to the existing ucap facility, to make it Ada compliant

UCTC: and to modernize their their maintenance facility.

UCTC: And we're setting aside 12.5 million dollars in FDA, funding for the construction of a new Ucap bus storage and maintenance facility. The location is yet to be determined. The needs were determined preliminary needs through a 2019 study that Uctc. Did on behalf of Ulster County Government.

UCTC: The electrification of the fleet has created significant storage and capacity needs.

UCTC: and the fleet has essentially outgrown its current facility at Golden Hill. So we'll be looking to provide what would probably be a minimum of 12.5 million for the construction of that facility within the next 3 to 4 years, we'd like to see construction.

UCTC: So it's also important to announce that the New York State Department of Transportation has provided 4

UCTC: at least 2 new projects and 4 ongoing projects that are significant investments in the Ulster County transportation system. The Shandakin routes 212 and 214 that's in Shandakin and Woodstock has a significant slope. Repair project

UCTC: to those roads that's been programmed for a while now, but not to this. I've heard about the design. Yes, we we had set aside some money for engineering, only it's going really well. So now we're comfortable assigning the construction funds right? 18 million dollars in Federal aid. And these are just Federal numbers, too. There's a state match requirement of 20%. Or it may, it may vary by program

UCTC: the match requirement. But that's a significant project. Route 212 in Woodstock. This design process has been ongoing for the replacement of several culverts

UCTC: construction project that will include pedestrian enhancements. If if that's at least included in the description.

UCTC: you know the extent to which those pedestrian enhancements are constructed, I think, is to be determined at this point. Yeah, so this is a great project, too. So we're like replacing. I want to



say, it's 4 bridges, 3 or 4 bridges in the corridor, and then also looking at you know, addressing the sidewalks in the village proper.

UCTC: And then what happened over the past year was as part of our public outreach. We heard a lot about wanting to make you know, a good kind of bike pen connection between the village of Woodstock and Bearsville.

But for the engineering to be done in the Environmental Review, I think, will really help with the application. So it was kind of like we might not be able to afford it now for construction. But let's look at it from an engineering standpoint.

UCTC: So that in the future, even through funds here at Ucp, you know what I mean? It'll be yeah, that's fantastic. I think so, because again, these these federally projects are a big burden for municipalities. And to have that engineering backing and assistance from the department is is a huge benefit. Yeah.

UCTC: 2 new projects as well. Washington Avenue in the city of Kingston State. Dot has included on this transportation improvement program over 15 million dollars

UCTC: for intersection and operational improvements on the corridor between Schwank Avenue and Sawkill Road. That's Washington Avenue in the city of Kingston. We did receive quite a few public comments on this project in particular, and as a result of those projects, we did make a change. The Department changed the project description.

UCTC: which I believe, is on page 33.

UCTC: This is project PIN 8, 8, 1, 7, 5, 9. The Department changed the project description to specifically reference. The Onw rail trail crossing as part of within the project scope. So we appreciate the department responding to public comments in that regard as well. Design is not



scheduled for obligation until 2027 for this project, which construction at this point estimated to be in the year 2030,

UCTC: and then finally, a new. Another new project is Route 208 intersection in Shanga. That triangle intersection. As you're heading north, south through the town, 10.5 million in highway Safety Improvement program funding for operational improvements at that intersection. Which, again, has construction estimated for or construction. I'm sorry.

UCTC: And also it's important to mention the multi-county investments that are programmed on our transportation improvement program. There are a variety of specific project areas that the department puts in essentially lump sums across several pins for issues such as bridge, maintenance, pavement, improvements.

UCTC: And then, finally, we like to highlight projects that were completed during the previous Federal fiscal year. And so there's a list of some of the important projects, including bridge and trail and highway projects, over 23 million dollars and Federal aid was obligated during the previous tip cycle.

UCTC: The word Street Bridge was actually that was obligated in the tip cycle even prior to that in 2020. But we'd like to highlight it because it was such a significant investment in Ulster County over 50 million dollars to rehabilitate that historic bridge in Kingston

UCTC: the Tilson Avenue project, which was a Barton and Lajudas designed project in the town of Boyd

UCTC: New York State dot the signal in the town of Gardener. The intersection of 44, 55, and Brunswick Road is now operational.
